We reverse T.C.'s adjudication of delinquency for committing the offense of "possession of a firearm by a convicted felon" under section 812.133, Florida Statutes (2006). Because the State failed to prove that T.C. knowingly possessed the gun, we reverse. See, e.g., W.C. v. State, 914 So.2d 1100, 1101 (Fla. 1st DCA 2005). We find no merit in T.C.'s arguments concerning the constitutional defects of the police search and confession. The juvenile court properly found that probable cause existed to stop T.C., and that the search of his person was reasonable. See J.F. v. State, 897 So.2d 489, 490 (Fla. 4th DCA 2005) (finding probable cause for a search based on victim's statement that her son had a gun on his person at the time of the incident). T.C. was not in custody at the time he made the confession, so Miranda warnings were not required. See Y.K. v. State, 912 So.2d 517, 523-24 (Fla. 4th DCA 2005) (noting that a Miranda warning is required only where a defendant is in police custody). Reversed. WARNER and MAY, JJ., concur.
