

A: It seems that the page you are trying to load is loading from a.php file. When PHP parses the html file, the onclick events are removed, because all links and onclick events are separated from the page using php includes. You need to have the page be parsed by the browser (e.g. by adding an tag at the top of the file) and prevent the use of scripts / onclick etc, to prevent this from happening. A: I have the same problem and solved using DOMdocument::loadHTMLFile("file.html") instead of parser or reader... New Jersey Division of Consumer Affairs The Division of Consumer Affairs is a law enforcement agency within the executive branch of the state government of New Jersey in the United States. The Division of Consumer Affairs has 4,093 employees including 1,065 law enforcement officers and a statewide enforcement network that includes 21 field offices and offices throughout New Jersey. The Division was founded in 1934 with the assignment of responsibilities to the former Division of Labor. The Division is a part of the larger New Jersey Department of Law and Public Safety. The Division is led by a Director, appointed by the Governor of New Jersey, who is aided by an Executive Deputy Director, who serves as the Chief of Staff for the Director. The Division is overseen by a Commission on Crime and Safety, composed of the Governor's designee, the Director of the Division of Law and Public Safety, the Commissioner of the New Jersey Division of Consumer Affairs, the Director of the State Police, and the Executive Deputy Director. The Division is responsible for the enforcement of Federal trade laws, the Uniform Commercial Code, the Motor Vehicle and Motor Vehicle Safety Acts, the Truth-in-Lending Act, the Fair Debt Collection Practices Act, state debt collection laws, consumer loans, motor vehicle and property related issues, motor vehicle insurance, and motor vehicle repairs. Division of Consumer Affairs Enforcement Officers are authorized to carry firearms to perform investigations on behalf of the Division of Consumer Affairs and the New Jersey State Police (NJSP). In addition to enforcement officers, the Division has investigators, forensic accountants, insurance investigators, and law students that investigate cases and prepare reports that are used by the prosecutors and judges in their jurisdiction.
